

# **RVBAT Meeting - May 7, 2025**

## **Meeting Purpose**

Discuss digital equity initiatives, challenges, and opportunities in Southern Oregon counties.

## **Key Takeaways**

- Libraries face challenges with hotspot programs, including device loss and rural connectivity issues
- T-Mobile's network improvements may expand rural coverage, especially after acquiring U.S. Cellular
- Funding uncertainties and program cuts (e.g. e-rate hotspot checkout) are impacting digital equity efforts
- Innovative solutions like pharmacy lockers are being explored to improve healthcare access in rural areas

## **Topics**

### **Hotspot Programs and Connectivity Issues**

- Jackson County Library experiencing 40% loss rate with hotspot devices, considering sunsetting program
- Josephine County Library continuing hotspot program successfully, seeing increased demand
- Rural areas still face significant connectivity challenges even with hotspots
- T-Mobile network improvements:
  - Acquired Sprint system, building out "world's finest 5G network"
  - Recent acquisition of U.S. Cellular (~4,000 towers) may improve rural coverage soon
  - Future integration with Starlink satellites could provide 2-20 Mbps in areas without traditional coverage

### **Funding and Program Challenges**

- Oregon Digital Equity Program grant (\$500k minimum) has restrictive requirements
- E-rate hotspot checkout program for schools/libraries voted down in Senate, likely to be cut
- Organizations seeking creative funding solutions and partnerships to continue digital equity work

## **Innovative Solutions for Rural Access**

- Pharmacy lockers with video/audio capabilities being tested in Wheeler County
  - Could improve prescription access in areas with limited pharmacy hours
  - Raises questions about security, HIPAA compliance, and appropriate locations
- Libraries extending Wi-Fi coverage to parking lots for after-hours access
- Community health workers using library hotspots to connect homebound clients with healthcare providers

## **Digital Literacy Initiatives**

- Josephine Community Library:
  - Graduated 15 participants from 6-week computer basics class in Cave Junction
  - Partnering with U.S. Cellular for smartphone training sessions
  - Success story: Cave Junction resident completed training, now helping teach classes and becoming library assistant
- Jackson County Library partnering with AGE+ for digital literacy classes
